January 14, 2020

The organizational meeting of the Mason County Board of Commissioners was held at 9:00 a.m. in the Commissioners' Room located in the Mason County Courthouse in the City of Ludington.

The meeting was called to order by Clerk C. Kelly.

N. Krieger, G. Castonia, C. Lange, L. Squires, Roll call was taken. Present: S. Hull, J. Andersen, R. Bacon Absent: None.

Invocation was given by R. Bacon. Pledge of Allegiance to the flag of the United States of America followed.

Motion by L. Squires and seconded by R. Bacon to approve the agenda. Motion carried.

Clerk Kelly asked Commissioner Lange to bring forth a resolution for a one-year term for Chairperson. Motion by C. Lange and seconded by S. Hull to approve the following resolution:

HONORABLE COMMISSIONERS

WHEREAS, Public Act 392 of 2000 amends section 3 of Public Act 156 of 1851 specifying that the chairperson of a county board of commissioners shall be elected each odd-numbered year to serve a two-year term, unless the county board of commissioners provides by resolution that the chairperson shall be elected annually for a one-year term; and

WHEREAS, Public Act 392 took effect on January 4, 2001; and

WHEREAS, the Board of Commissioners of the County of Mason desires to elect its chairperson on an annual basis.

THEREFORE BE IT RESOLVED, that the Board of Commissioners of the County of Mason does hereby determine to elect its chairperson for annual one-year terms in accordance with the terms of Public Act 392 of 2000.

Clerk Kelly opened the floor for nominations of the Board Chair position. Commissioner Castonia nominated Commissioner Andersen; this was seconded by Commissioner Lange. There were no other nominations from the floor. Clerk Kelly asked again for nominations. None were given.

Motion was made by Commissioner Krieger to close nominations, requested to suspend the ruling with the by-laws and cast a unanimous vote to elect Commissioner Andersen as Mason County Board Chair. This was seconded by Commissioner Lange. Motion carried.

Clerk Kelly turned the meeting over to Chairperson Andersen at this time.

Commissioner Andersen thanked the Board for their votes and stated that she looks forward to her continued work with them and serving the citizens of Mason County.

Chair Andersen then opened the floor for nominations for Vice-chair.

Commissioner Lange nominated Commissioner Hull for Vice-Chair. This nomination was seconded by Commissioner Castonia.

Motion was then made by Commissioner Krieger to close nominations, requested to suspend the ruling with the by-laws and cast a unanimous vote to elect Commissioner Hull as Vice-Chair of the Mason County Board of Commissioners. This was seconded by Commissioner Lange. Motion carried.

Motion by R. Bacon and seconded by N. Krieger to approve the minutes of the December 10, 2019 Regular Meeting and December 26, 2020 Special Meeting. Motion carried.

No correspondence was read.

Ken Ferwerda, President of the Western Michigan Fair Association, wished to thank the Mason County Board of Commissioners for their continued support. He notes that two barn projects have been completed and that the Fair Board has no current issues and is on-target for the 2020 year. There has been an issue with H2B Visa with Carnivals closing due to no workers and encouraged everyone to reach out to speak with their State Senator and Representatives to make the program better.

Chairwoman Andersen thanked the Fair Association for all of the volunteer hours and the work done to offer an amazing facility for our county. Their efforts have not gone unnoticed.
