July 11, 2017

The regular meeting of the Mason County Board of Commissioners was held at 9:00 a.m. in the Commissioners' Room located in the Mason County Courthouse in the City of Ludington.

The meeting was called to order by Chairman C. Lange.

Roll call was taken. Present: W. Taranko, B. Carpenter, C. Lange, L. Squires,

S. Hull, J. Andersen.

Absent: T. Posma.

Invocation was given by C. Lange. Pledge of Allegiance to the flag of the United States of America followed.

Motion by T. Posma and seconded by S. Hull to approve the agenda. Motion carried.

Motion by J. Andersen and seconded by S. Hull to approve the minutes of the June 13, 2017 Regular Meeting. Motion carried.

No correspondence was read.

Public comment:

- Michigan State University Extension District 5 Coordinator Mike Krauch wished to thank Commissioners Andersen and Taranko for coming out to the open house held at the new office. He also wished to personally thank Commissioner Carpenter for his work as an At-Large member involved with MSU Extension and it has been a privilege to have worked alongside Commissioner Carpenter.
- City of Ludington Mayor Kay Ferguson-Holman thanked Commissioner Carpenter for his service as District #2 Commissioner. Additionally, she gave a recommendation on behalf of Gary Castonia who applied to the open seat, stating the County would be receiving a wonderful asset should they appointment him. He would dearly be missed on City of Ludington Council.

Emergency Management Coordinator Liz Reimink gave her annual report and highlighted potential changes in the way that the Homeland Security Grant funding will be processed. She briefly reviewed with the Commissioners many of the topics that she has worked on over the past year.

Coordinator Reimink also noted that she and intern Dr. Kristopher Appler had the privilege to assist Isabella County for three days after their recent inclement weather that created extreme flooding in Isabella County. This work provided insight on ways to improve disaster response capabilities in Mason County.

Commissioner Andersen noted that she was able to participate in a recent table top exercise and commended Emergency Manager Reimink on her work.
