Administrator Knizacky noted that the 2017 Audit has been completed and that it will be presented to the Board at the August Board Meeting. He noted that he is working on 2018 mid-year budget amendments and the 5-year capital improvement plan with the department heads and elected officials.

Public Comment:

• Ms. Beth McGill-Riezer pointed out what she felt was a typographical error on the agenda related to the resolution read by Chairman Lange regarding the Area Agency on Aging. The year should have been 2019 not 2018. She was thanked for pointing out this error.

• Senator Darwin Booher noted that with the Homeland Security there was additional funding set aside for schools and if Emergency Manager L. Reimink was in charge of schools, he would assist her in this. Unfortunately, E.M. Reimink only assists in developing and writing of school plans. That the Schools in Mason County have formed a School Safety Team.
