Chair Andersen noted that the entire board needed to be advised that under the new FAA guidelines, the airport was going to lose 900 feet of runway at the Mason County Airport. There are a number of options available and presented by Airport Manager J. O'Connor. Significant discussion ensued with the multiple questions from Commissioners' being answered by Airport Manager O'Connor. If the County choose the option to keep the 900 feet and maintain the runway at 5000 feet, it would cost the County approximately \$1.2 million to complete the initial project with an annual fee of \$10,000.00. Administrator Knizacky and Airport Manager O'Connor are scheduled for a meeting at the end of September with the Michigan Office of Aeronautics and will inform the Board of any new information should it arise.

Two local units exercised their right of refusal on parcels (Pere Marquette and Fountain Village). Twelve parcels are left to go to auction on October 6<sup>th</sup>, 2020.

Clerk C. Kelly presented the monthly Clerk's Report.

Administrator Knizacky presented the Administrator's Monthly Report. Administrator Knizacky noted that there are several grant applications through the State. Currently, he has applied for six different COVID-19 grants. After review of the requirements, he is recommending that the County not apply for the CBDG Grant. He will be participating in a webinar for the Coronavirus Relief Local Government (CRLGG) Program to see what the County is eligible for.
