<u>WHEREAS</u>, on August 11, 2020, the Mason County Board of Commissioners received and reviewed the proposed Master Plan prepared by the Planning Commission, authorized distribution of the Master Plan to the

Notice Group entities identified in the MPEA, and asserted its right to give final approval or rejection of the Plan; and

WHEREAS, notice was provided to the Notice Group entities as provided in the MPEA; and

<u>WHEREAS</u>, the Mason County Planning Commission held a public hearing on November 17, 2020 to consider public comment on the proposed Master Plan and to further review and comment on the proposed Plan; and

<u>WHEREAS</u>, after the public hearing was held, the Planning Commission voted to approve the updated Plan on November 17, 2020 and recommended adoption of the proposed Master Plan to the Mason County Board of Commissioners; and

<u>WHEREAS</u>, the County Board of Commissioners finds that the proposed Master Plan is desirable, proper, reasonable, and furthers the use, preservation, and development goals and strategies of the County.

NOW, THEREFORE BE IT RESOLVED AS FOLLOWS:

- **1. Adoption of the 2020 Master Plan.** The Mason County Board of Commissioners hereby approves and adopts the proposed 2020 Mason County Master Plan including all of the chapters, figures, descriptive matters, maps and tables contained therein.
- **2. Distribution to the Notice Group.** Pursuant to MCL 125.3843 the Mason County Board of Commissioners approves distribution of the updated Master Plan to the Notice Group.
- **3. Findings of Fact.** The Mason County Board of Commissioners has made the foregoing determination based on a review of existing land uses in the County, a review of the existing Master Plan provisions and maps, and input from the Planning Commission and the public, as well as the assistance of a professional planning group. The County Board of Commissioners also finds that the updated Master Plan will accurately reflect and implement the County's goals and strategies for the use, preservation, and development of lands within Mason County.
- **4. Effective Date.** The amended Master Plan shall become effective on the adoption date of this resolution.

- Treasurer A. Kmetz presented the monthly Treasurer's Report. Treasurer Kmetz noted that it has been a busy month thus far for his office. His Chief Deputy was elected to the City of Ludington Treasurer position and he has hired Caleb Wagner. He thanked the board for allowing to hire early for training purposes. Treasurer Kmetz noted that the State of Michigan has released the new Chart of Accounts and he hopes to be utilizing those in April or May 2021.
- Clerk Kelly distributed the Clerk's report. The Clerk's Office is not done with the November 3, 2020 election yet. The office is working on an upcoming recount for the City of Ludington 5Th Ward Councilor. This event will be on Friday, December 11, 2020 at 9 a.m. at City Hall. Additionally, the state has issued three audits for Branch, Riverton, and Victory Townships. These audits will be conducted with Clerk Kelly and the Clerk from each respective township on December 15, 2020. Finally the State also will have a Risk Limiting Audit for the November 3, 2020 election scheduled in January 2021. The Clerk Office is in full swing for year-end. Clerk Kelly noted that the State Court Administrator's Office requested that Mason County be part of a pilot program for the Trial Court. Determination at this time is not final. Clerk Kelly is hoping to hold off this request until after February 2021.
- Administrator Knizacky reported that there are still open seats on the Zoning Board of Appeals Alternate and the Mason County Brownfield Redevelopment Committee. These seats will need to be filled and encouraged commissioners to reach out to residents to apply for these seats.

Additionally, he noted that it has been three years since the Mason County Board of Commissioner's became the only County Board to sponsor a Promise Zone Board. Under the rules, the Promise Zone was able to fundraise monies for the first two years. Now in year three, funding will come from the State of Michigan and he is happy to report to the Board that the first payment was received this week.
