The regular meeting of the Mason County Board of Commissioners was held at 7:00 p.m. at the Mason County Airport terminal conference room in Ludington.

The meeting was called to order by Chair J. Andersen

Roll call was taken. Present: N. Krieger, G. Castonia, C. Lange, L. Squires,

S. Hull, J. Andersen, R. Bacon

Absent: NONE

Invocation was given by R. Bacon and pledge to the flag followed.

Approval of the Agenda with the addition of the closed session minutes. Motion by S. Hull and seconded by J. Hartley to add the item to the agenda. Motion carried.

Motion was made by N. Krieger and seconded by S. Hull to approve the minutes of the 8-2-21 Closed Session minutes. Commissioner Squires Abstained from the vote due to his absence at that meeting. Motion carried.

No correspondence was read.

Public comment: Gene Kyle, Ludington, is requesting answers regarding funding for the senior services and the millage. He asked multiple questions regarding the senior millage and how the County decides what to levy. He submitted the document he read at the meeting to the County Clerk to become part of the official record for the August meeting.

James Kelly, Michigan State University Extension, informed the Board on events taking place at this time within the MSU-E organization. He thanked Commissioner Hull for attending the new fruit and vegetable research station in Hart, Michigan. He noted that he will be emailing the information he spoke about this evening to the Commissioners in the near future and to share the information with the public.

West Michigan Community Mental Health System Director, Lisa Hotovy-Williams, spoke to the Board regarding Senate Bills 597 and 598, as well as House Bills 4925-4929, and her request of the Mason County Board to approve a resolution opposing those bills. She provided historical information regarding the current programs and why the passing of the new bills should not be supported.

Commissioners Castonia, Squires, and Hartley asked further questions regarding these bills.

MICHIGAN COMMUNITY RESOLUTION AND INTERGOVERNMENTAL AGREEMENT TO MANAGE FLOODPLAIN DEVELOPMENT FOR THE NATIONAL FLOOD INSURANCE PROGRAM

Community A: Summit Township Community/Entity B: Mason County

<u>WHEREAS</u>, Summit Township currently participates in the Federal Emergency Management Agency's (FEMA) National Flood Insurance Program (NFIP) by complying with the program's applicable statutory and regulatory requirements for the purposes of significantly reducing flood hazards to persons, reducing property damage, reducing public expenditures, and providing for the availability of flood insurance and federal funds or loans within its community; and

<u>WHEREAS</u>, the NFIP requires that floodplain management regulations must be present and enforced in participating communities, and utilize the following definitions which also apply for the purposes of this resolution:

• Flood or Flooding means:

- A general and temporary condition of partial or complete inundation of normally dry land areas from: 1) the overflow of inland or tidal waters, 2) the unusual and rapid accumulation or runoff of surface waters from any source, 3) mudflows, and
- The collapse or subsidence of land along the shore of a lake or other body of water as a result of erosion or undermining caused by waves or currents of water exceeding anticipated cyclical levels or suddenly caused by an unusually high water level in a natural body of water, accompanied by a severe storm, or by an unanticipated force of nature, such as flash flood or an abnormal tidal surge, or by some similarly unusual and unforeseeable event which results in flooding, as defined in paragraph (a)(1) of this definition.
- <u>Flood Hazard Boundary Map (FHBM)</u> means an official map of a community, as may have been issued by the FEMA, where the boundaries of the areas of flood, mudslide (i.e., mudflow) related erosion areas having special hazards have been designated as Zone A, M, and/or E.

- <u>Floodplain</u> means any land area susceptible to being inundated by water from any source (see definition of flooding).
- <u>Floodplain management</u> means the operation of an overall program of corrective and preventive measures for reducing flood damage, including but not limited to emergency preparedness plans, flood control works, and floodplain management regulations.
- <u>Floodplain management regulations</u> means zoning ordinances, subdivision regulations, building codes, health regulations, special purpose ordinances (such as a floodplain ordinance, grading ordinance, and erosion control ordinance) and other applications of police power that provide standards for the purpose of flood damage prevention and reduction.
- <u>Structure</u> means a walled and roofed building that is principally above ground, gas or liquid storage facility, as well as a mobile home or manufactured unit.

<u>WHEREAS</u>, the Stille-Derossett-Hale Single State Construction Code Act", Act No. 230 of the Public Acts of 1972, as amended, (construction code act), along with its authorization of the state construction code composed of the Michigan Residential Code and the Michigan Building Code [and its Appendices (specifically Appendix G)] contains floodplain development and management regulations that comply with the FEMA NFIP minimum floodplain management criteria for flood prone areas as detailed in Title 44 of the Code of Federal Regulations (44 CFR), Section 60.3, and

<u>WHEREAS</u>, by the action dates of this document or an existing historical agreement dated August 24, 2021, Mason County affirms/agrees on behalf of Summit Township to function as the designated enforcing agency to discharge the responsibility of administering, applying, and enforcing the construction code act and the state construction code, specifically the Michigan Residential Code and the Michigan Building Code, and the Michigan Rehabilitation Code for Existing Buildings to all development within Community A's political boundaries, and

<u>WHEREAS</u>, Summit Township and Mason County enforce floodplain regulations of the construction code act, and Summit Township wishes to ensure that the administration of that code complies with requirements of the NFIP, and

NOW THEREFORE, to maintain eligibility and continued participation in the NFIP,

- Summit Township and Mason County agree that Mason County's officially designated enforcing agency for the construction code act, Mason County Building Inspector, be directed to administer, apply, and enforce on Summit Township's behalf the floodplain management regulations as contained in the state construction code (including Appendix G) and to be consistent with those regulations, by:
 - Obtaining, reviewing, and reasonably utilizing flood elevation data available from federal, state, or other sources pending receipt of data from the FEMA to identify the flood hazard area, and areas with potential flooding, and
 - Ensuring that all permits necessary for development in floodplain areas have been issued, including a floodplain permit, approval, or letter of no authority from the Michigan Department of Environmental Quality under the floodplain regulatory provisions of Part 31, "Water Resources Protection," of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, and
 - Reviewing all permit applications to determine whether the proposed building sites will be reasonably safe from flooding. Where it is determined that a proposed building will be located in a flood hazard area or special flood hazard area, Mason County shall implement the following applicable codes according to their terms:
 - All appropriate portions and specifically the floodplain management regulation portions and referenced codes and standards of the current Michigan Residential Code.
 - All appropriate portions and specifically the floodplain management regulation portions and referenced codes and standards of the current Michigan Building Code.
 - Appendix G of the current Michigan Building Code.
 - All appropriate portions and specifically the floodplain management regulation portions and referenced codes and standards of the current Michigan Rehabilitation Code for Existing Buildings.
 - Reviewing all proposed subdivisions to determine whether such proposals are reasonably safe from flooding and to ensure compliance with all applicable floodplain management regulations.
 - Assisting in the delineation of flood hazard areas; provide information concerning uses and occupancy of the floodplain or flood-related erosion areas, maintain flood proofing and lowest floor construction records, and cooperate with other officials, agencies, and persons for floodplain management.
 - Advising FEMA of any changes in community boundaries, including appropriate maps, and

- Maintaining records of new structures and substantially improved structures concerning any certificates of floodproofing, lowest floor elevation, basements, floodproofing, and elevation to which structures have been floodproofed.
- Summit Township and Mason County assure the Federal Insurance Administrator (Administrator) that
 they intend to review, on an ongoing basis, all amended and revised FHBMs and Flood Insurance Rate
 Maps (FIRMs) and related supporting data and revisions thereof and revisions of 44 CFR, Part 60,
 Criteria for Land Management and Use, and to make such revisions in its floodplain management
 regulations as may be necessary to assure Summit Township's compliant participation in the program.
- Summit Township further assures the Administrator that it will adopt the current effective FEMA Flood Insurance Study (FIS), FHBMs, and/or the FIRMs by reference within its Floodplain Management Map Adoption Ordinance or similarly binding ordinance documentation.

<u>FURTHER BE IT RESOLVED</u>, both communities declare their understanding that, until this resolution is rescinded or Summit Township makes other provision to enforce the construction code act:

- Mason County must administer and enforce the construction code act in accordance with the terms and the conditions contained herein, and
- For Summit Township to continue its participation in the NFIP, the construction code act must be administered and enforced according to the conditions contained herein.

<u>WHEREAS</u>, Section 528 (MCL 600.528) as amended by 2012 PA 18 of the Revised Judicature Act of 1961 created the Twenty-Seventh Judicial Circuit Court as a circuit court for the counties of Newaygo and Oceana with one judge, and

<u>WHEREAS</u>, Section 549c (MCL 600.549c) of the Revised Judicature Act of 1961 created the Fifty-First Judicial Circuit Court as a circuit court for the counties of Lake and Mason with one judge, and

<u>WHEREAS</u>, Section 8143 (MCL 600.8143) as amended by 2002 PA 92 of the Revised Judicature Act of 1961 created the Seventy-Eighth District Court as a first-class district court for the counties of Newaygo and Oceana, and

<u>WHEREAS</u>, Section 8144 (MCL 600.8144) as amended by 2020 PA 82 of the Revised Judicature Act of 1961 created the Seventy-Ninth District Court as a first-class district court for the counties of Lake and Mason, and

<u>WHEREAS</u>, proposed law has been drafted to modify circuits and districts for Lake, Mason, Newaygo, and Oceana Counties from Newaygo/Oceana and Lake/Mason to Lake/Newaygo and Mason/Oceana, and

<u>WHEREAS</u>, all judges of Lake, Mason, Newaygo, and Oceana Counties have determined that realignment of the circuit and district courts would better serve the counties' populations by increasing efficiency and equalizing judicial caseloads and recommended it to the Mason County Board of Commissioners, and

<u>WHEREAS</u>, Section 550a (MCL 600.550a) of the Revised Judicature Act of 1961 requires that, "if a new judicial circuit is proposed by law, that new circuit shall not be authorized or filled by election unless each county in the proposed circuit, by resolution adopted by the county board of commissioners, approves the creation of the new circuit," and

<u>WHEREAS</u>, Section 8176 (MCL 600.8176) of the Revised Judicature Act requires that, "if a new district is proposed by law, that new district shall not be authorized or filled by election unless each district control unit in the proposed district, by resolution adopted by the governing body of the district control unit, approves the creation of the new district, and

<u>WHEREAS</u>, the Mason County Board of Commissioners and the Oceana County Board of Commissioners are the governing bodies of the counties for which the changes in circuits and districts are proposed.

<u>NOW THEREFORE, BE IT RESOLVED</u>, that the Mason County Board of Commissioners does hereby give its approval to adopt the law and modify the 51st Circuit Court to include Mason and Oceana Counties and the 79th District Court to include Mason and Oceana Counties.

FURTHER, THE MASON COUNTY TRIAL COURT CHIEF JUDGE IS DIRECTED TO FORWARD THE RESOLUTION TO SENATOR VANDERWALL, REPRESENTATIVE O'MALLEY AND THE STATE COURT ADMINISTRATOR'S OFFICE.

Commissioner Krieger noted that he would be voting no on this resolution as he feels this request would cost the County more money. He stated this combination would force the Circuit Court Judge's position to be split and feels this would take away time from Mason County constituents. Commissioner Squires inquired of the Judges' stand on this and was informed that the Chief Judge came before the Public Safety and Courts Committee to address this, and it was endorsed by that committee. No information, nor discussion has taken placed regarding cost sharing between Mason and Oceana County's at this time. Commissioner Hartley noted that the Judges are in favor of this; therefore, it should be supported.

<u>WHEREAS</u>, Michigan's public behavioral health system is leading the nation in implementing evidence-based integrated care at the community level; and

<u>WHEREAS</u>, the fundamental components of Senate Bills 597 and 598 and House Bills 4925-4929 would shift Medicaid financing and managed care functions from the public behavioral health system to a private Medicaid health plan system and eliminate public oversight, public accountability and public governance; and

<u>WHEREAS</u>, the proposals specifically incentivize and prioritize profits to private Medicaid health plans at the expense of the public and the citizens served by the public behavioral health system; and

<u>WHEREAS</u>, the current public system is the fiscally responsible way to manage costs. The overhead of a private health plan is 2.5 times higher than the current public system. Privatizing the state's behavioral health system would mean an immediate \$300 million loss in dollars for persons served; and

WHEREAS, the proposals focus on financial integration. Integration must begin at the patient level; and

<u>WHEREAS</u>, the proposals would threaten the ability of Community Mental Health Service Providers to deliver services thus putting the recovery of a number of Michigan citizens at risk; and

<u>WHEREAS</u>, the drastic and complex overhaul of the public behavioral health system would create new costs, new complexity and other barriers to care, putting the mental wellbeing of thousands of Michigan citizens at risk; and

<u>WHEREAS</u>, navigating this change in the midst of a pandemic will only add to the stress and concerns of those served; and

<u>WHEREAS</u>, state lawmakers are attempting to move the legislation on a short timeline, which does not allow for meaningful stakeholder involvement, proof of concept, or buy-in.

<u>NOW, THEREFORE, BE IT RESOLVED</u>, that the Board of Commissioners of the County of Mason opposes Senate Bills 597 and 598 and House Bills 4925-4929. We believe any behavioral health redesign must maintain the efficacy, responsiveness and integrity of the community-based behavioral health system; and

<u>BE IT FURTHER RESOLVED</u>, that certified copies of this resolution be sent to Governor Gretchen Whitmer, Senator Curt VanderWall, Representative Jack O'Malley, Senator Mike Shirkey and Representative Mary Whiteford.

He is requesting input from the board regarding budget work sessions for the 2022 final budget, possible dates are September 27 or September 28, 2021. Please let him know what date would work best.

Public comment: Tom Bogner, Fountain, thanked the Board of Commissioners for the approval of the Outdoor Assembly event.

Unfinished business: Chair Andersen reminded board members to turn in their priority lists by August 16, 2021 to her.

Commissioner Squires spoke regarding transparency with good government and inquired of who is in charge to respond back to questions addressed to the board. Chair Anderson noted that Public Comment was a time for the Public to speak, not a question and answer session. The Public is always invited to attend all Committee meetings and speak at that time to Commissioners. She personally invited Mr. Kyle and his parties to attend the next Finance, Personnel & Rules Committee Meeting on August 17, 2021 at 9 a.m. at the Mason County Airport Conference room. It would be at this meeting that the public could address board members and have their questions answered.

Additionally, she noted that the board has always been supportive of services, but sometimes there are breakdowns in services provided. Is the system broken? Yes. How to address the issues have not been changed because the people involved in those issues didn't want to change.

With no other business the meeting was adjourned at 8:25 p.m.
