January 14, 2014

The regular meeting of the Mason County Board of Commissioners was held at 9:00 a.m. in the Commissioners' Room located in the Mason County Courthouse in the City of Ludington.

The meeting was called to order by County Clerk Jim Riffle.

Roll call was taken. Present: J. Lenius, B. Carpenter, C. Lange, C. VanderWall,

M. Nichols, J. Andersen, T. Posma

Absent: None.

Invocation was given by Clerk Riffle. Pledge of Allegiance to the flag of the United States of America followed.

Motion by C. VanderWall and seconded by B. Carpenter to approve the agenda with the addition of a resolution of an appointment to the Area Agency on Aging of Western Michigan, Inc. Board of Directors. Motion carried.

Clerk Riffle explained that the Board Chair could be elected for either a one-year or two-year term and if a one-year term was desired as in the past, a motion needed to be passed stating the term would be for one year. Motion by C. VanderWall and seconded by B. Carpenter to elect the Board Chair for a one-year term. **Motion carried.**

Clerk Riffle also explained that by law the election of the Board Chair of the County Board was the only time Commissioners were allowed to vote by secret ballot and only if a motion was passed by the full County Board. No motion was made regarding voting by secret ballot.

Clerk Riffle opened the floor for nominations of the Board Chair position. C. VanderWall nominated Commissioner Lange. Clerk Riffle asked if there were any other nominations from the floor and with no other nominations brought forward a motion was made by C. Lange and seconded by B. Carpenter to close nominations and elect Commissioner Lange as the Mason County Board Chairman for 2014. **Motion carried.**

Clerk Riffle opened the floor for nominations for the Board Vice-Chair position. M. Nichols nominated Commissioner Carpenter and T. Posma nominated Commissioner VanderWall. Clerk Riffle asked if there were any other nominations from the floor and there being none Clerk Riffle proceeded with a roll call vote with the following results: Carpenter three votes - Carpenter, Nichols, and Andersen; VanderWall four votes - Lenius, Lange, VanderWall, and Posma. Commissioner VanderWall was elected as Vice-Chairman of the Board of Commissioners for 2014. Clerk Riffle then turned the meeting over to Chairman Lange who thanked his fellow Commissioners for their support in electing him as Chairman of the Board.

Motion by T. Posma and seconded by J. Lenius to approve the minutes of the December 10, 2013 regular meeting and the December 30, 2013 Special Meeting. Motion carried.

Chairman Lange made reference to correspondence in the agenda packet from Jim Hissong as well as correspondence handed out prior to the meeting from AT&T and a Legislative Analysis from State Representative Franz regarding Senate Bill 636.

Public Comment:

Amber Township Supervisor Jim Gallie stated that the township's ORV ordinance became effective January 13th and also thanked the county for partnering with Amber Township in the Federal Flood Insurance program.

Wayne Schoonover introduced himself as the new Director of the Mason County Road Commission.

Jim Hissong of East Bockstanz Road in Branch Township updated Commissioners on his dealings with the Mason County Road Commission regarding the maintenance of his road. Mr. Hissong stated that the speed plow truck drivers grade his road determines whether the job is done properly or results in gravel being thrown off the road.
